NEW BRANCHES ON OUR FAMILY TREE

The Hildreth Highlights of January 1984 states that it is not necessarily the case that all Hildreths in the USA are descended from the 1635 Hildreths. Richard¹ of Massachusetts or Thomas¹ of Long Island Indeed, this article is about three Hildreth brothers, James, John and Richard, who came to the USA in the 1980's. (But one look at their eyes reveals that they are related to the 1635 Hildreths somewhere along the line.) Almost 200 years ago in Northallerton, Yorkshire, England, Richard Hildreth (a school master) and his wife, Mary Wheatly, had six children. Three of the children were boys, James, John and Richard, Jr. These boys were born 1 year and 5 months and 1 year and 4 months apart! (Can you imagine a newborn, a 17 month old, and a not quite 3 year old all at the same time? Mary Wheatly Hildreth must have had her hands more than full!)

ames Hildreth, born 1826 Before he came to the USA, James Hildreth was the head waiter in a London restaurant. While he was still in England. James married Ellen Otley. When he came to the USA (in 1869), he founded the Hildreth Varnish Company in New York City. The Hildreth Varnish Company produced, among other things, the green paint for Pullman railroad cars. James Hildreth had four children. Mary Jane Hildreth, Ann Elizabeth Hildreth, James Hildreth, Jr. and George Otley Hildreth. Mary Jane died voung. Ann Elizabeth married Franklin P. Mason. James, Jr. never married. He was a salesman for the Winchester Repeating

Arms Company. George O. married Kate Elizabeth Evans. He became involved with the Hildreth Varnish Company (along with Ann's husband, Franklin Mason). Ann Hildreth, Franklin Mason, George Hildreth and Kate Evans have many descendants, of which the author is one.

John Hildreth, born 1827. John Hildreth was a bookkeeper in an iron works in Middlebrough, Durham County, England. When he came to the USA (in 1879), he became a cloth inspector. John married Mary A. Farlan in England and had eight children, four boys and four girls. One of the boys died young. The other three were Richard, John and James (repeating the names of the previous generation). Richard was a musician. John was a blacksmith, James assisted Richard with his music. The girls were Mary (also called Polly), Jane, Margaret and Clara (also called Nellie). John Hildreth's children have many descendants throughout the USA

Richard Hildreth, Jr., born 1828. Before he came to the USA, Richard Hildreth, Jr. was engaged in the textile business in Bradford, England. When he came to America (in about 1870), he became the head of one of the departments at the Farr Alpaca Company in Holyoke, MA. Richard married Martha Wood in England and had one child, John Hildreth. John married Kate B. Story. He followed his father to America and eventually became the head of another department at Farr Alpaca Company. Because of bad health, however, John had to leave the mill. This was probably the best thing that could have happened, because he took up the study of law, was admitted to the bar and, in time, became quite a famous judge in the Holyoke District. John Hildreth had five children, the most notable of whom was Ellison Story Hildreth. Ellison Hildreth was a minister and a missionary to China. (Much of the information in this article is taken from letters written in the 1930's from Ellison Hildreth to the Hildreth Family Association.) According to the January 1984 issue of Hildreth Highlights, one or more of Ellison's grandchildren, by the name of Ballou, are living in South Royalton, VT.

If you are a descendant of one of the three Hildreth brothers described here or if you know of anyone who is, I would love to hear from you. I have a lot more information on this branch of the Hildreth family tree, including photographs, that I would be glad to share. Actually, I have gone back two more generations than the family tree indicates. That brings this Hildreth line back to about 1730. I only have 100 years (!) to go to tie this line into the 1635 Hildreths, Richard¹ and Thomas¹.
