William Leckie was born in about 1840 in Menstrie, Logie Parish, Stirlingshire, Scotland. His parents were William Leckie, Sr. [born about 1804 in St. Ninians, Stirlingshire, Scotland] and Margaret Liddell [born 11 Mar 1798 in St. Ninians, Stirlingshire, Scotland.] His parents were married on 02 Dec 1827 in St. Ninians, Stirlingshire

William Leckie, Sr., was a Woolen Hand Loom Weaver. He died in 1862 at age 58 years due to injuries sustained in an accident, when his cart turned over.

William Leckie (Jr.) was born in Menstrie but moved to Alva with his family when he was just a few months of age.

William Leckie (Jr.) married Janet Thomson [born in about 1847 in Stirling, Stirlingshire, Scotland] on 10 August 1865 at Stirling Manse³ in Stirling, Stirlingshire, Scotland.

¹ Logie Parish is a parish of Stirlingshire, Clackmannanshire, and Perthshire, which contains most of the post town of Bridge of Allan, part of the royal burgh of Stirling, the villages of Causewayhead and Menstrie, and the hamlets of Blairlogie and Craigmill.

² As of 1891, Alva is in Clackmannanshire

³ A "manse" is the house occupied by a minister of a Presbyterian church.

During the Industrial Revolution (circa 1760 to 1830), Alva developed as a textile manufacturing center. The woolen mills were originally water-powered, powered by the water of Alva Burn. The mills produced textile products including tweed, woolen novelty fabrics, and mohair and woolen rugs. (Refer to the Appendix.)

In fact, William Leckie owned and operated a woolen mill in Alva. The mill produced tartan scarves and other products for the American market until the advent of powered looms caused closure of the mill.


The following article was published in the Alloa Journal on 04 June 1904:

The Late Mr. Wm Leckie

There passed away on Saturday evening last a member of a family which has played a not inconsiderable part in the social and public life of Alva during the past 60 years. Mr. Wm Leckie to whom we refer was practically a native of our burgh. Born in Menstrie, he was brought to Alva by his parents when he was only a few months old in the year 1841. He was early sent to learn the trade of a weaver and afterwards a warper, in which capacity he distinguished himself, acting for many years as a foreman to the late John Drummond then one of the leading manufacturers. On leaving there he along with his brother (Mr. Archibald Leckie) started business on their own account, and for many years the firm enjoyed a very high reputation both for the quality and design of the goods they placed on the market, and it was only when there was absolutely no demand for the higher priced shawls and plaids that the firm were compelled to give up business. On his retiral, being still an active and energetic man, he entered the employment of Provost Arnot who, by the way, served his time as an apprentice weaver in the shop of John Drummond during the period the deceased acted as foreman. Possessed of a strong will and forceful means of expression, Mr. Wm Leckie made his influence felt in almost all matters of a public nature which came up from time to time, and this may be particularly said of the affairs of the Co-Operative Bazaar society for which he acted as chairman for several years, and also of all matters affecting the woollen industry. He leaves a widow and a grown family of eleven sons and one daughter. Much sympathy has been expressed on all hands for the family in their bereavement.

Several of William's children moved away from Scotland. For example, Alexander Leckie, Thomas Liddell Leckie, and Peter Taylor Leckie all moved to Ottawa, Ontario, Canada. And John Taylor Leckie moved to Cleveland, Ohio, USA.

The picture below shows the children who moved. This picture was taken in 1921 in Canada when John Taylor Leckie was visiting from the USA, Margaret Leckie was visiting from Scotland, and Alexander Leckie, Thomas Liddell Leckie, and Peter Taylor Leckie were all living in Ottawa, Ontario, Canada.




Except for his first few months, William Leckie lived his entire life in Alva.

William Leckie died on 28 May 1904 at 139 Stirling Street in Alva, Stirlingshire, Scotland. He is buried in the Alva Cemetery along with his wife, Janet Thompson Leckie, and four of their children: William Charles Leckie, Margaret Leckie Laing, Isabella Leckie, and Edward Leckie.

The following is abstracted from the article "The Industries of Scotland: Woollen Manufacturers" from the website: http://www.electricscotland.com/history/industrial/industry9.htm. This article must have originally been written about 1870 because the last date mentioned is 1867.

ALVA.—The inhabitants of Alva are almost entirely dependent on the woollen manufactures. The population was 1150 in 1821; 2216 in 1841; and 3282 in 1861; and the trade of the place has increased at a like rate. Blankets and serges were the only goods produced up till 1829, when the manufacture of shawls was introduced. There are nine spinning-mills in the village, employed on yarns for making shawls, tartan dress goods, tweeds, &c. The mills contain thirty-seven sets of carding-engines, driven by steam and waterpower. The number of persons employed is about 220. The amount of raw material put through in the course of a year is valued at about £123,000. Some of the yarn is used in the place, but the greater part of it goes to agents in Glasgow.

The weaving of shawls, handkerchiefs, plaids, and shirtings is the staple trade of the village, and gives employment to about 693 journeymen and 99 apprentices in the busy season, besides from 500 to 600 women who do the winding, twisting, and finishing. A number of young boys are also employed as drawers and twisters. Since shawls and tartans ceased to be fashionable articles of female attire, and since the closing of the ports of the United States [probably due to the American Civil War 1861-1865] to our manufactured goods, trade has been limited to a few months of the year; and that circumstance presses hard on those employed in the weaving business, who generally seek work during the winter months in Hawick, Selkirk, Galashiels, &c.

The value of the manufactured goods runs from about £200,000 to £250,000 annually. The chief market is Glasgow, but a considerable quantity also goes to Manchester, London, and some of the principal Irish towns.

At Menstrie—a small village two miles distant from Alva—there is a large factory known as Elmbank Mill, owned by Messrs. Drummond & Johnstone. It contains eight sets of carding-engines, driven by a steam-engine of ninety horsepower. The machinery is of the most recent construction. The raw material used annually is valued at about £33,000, and the goods manufactured at double that amount.
